The same applies in the event that any portion of the funding for the Charitable Purpose is unused.

The Lung Cancer Patient Association certifies, as a result of entering into this Letter Agreement, regardless of legality, neither The Lung Cancer Patient Association, nor any of its directors, officers, or representatives have offered, promised, paid or provided any gifts, personal services, financial benefits of any other goods or services of value, either for ownership or lending, directly or indirectly to any employee, officer, agent or representative of any governmental body, agency or instrumentality for the purposes of or by extension suitable for influencing either directly or indirectly, decisions or actions liable to improperly influence or gain any unjustified advantage with respect to any business conducted by **MSD**.

The Lung Cancer Patient Association certifies that the funding (or any portion of it) shall not be provided to any of The Lung Cancer Patient Association's directors, officers or representatives for the purposes of influencing either directly or indirectly, decisions or actions liable to improperly influence or gain any unjustified advantage with respect to any business conducted by **MSD**.
  4. Funding provided by **MSD** to The Lung Cancer Patient Association shall be made in the same currency as the Request for Funding and shall be paid by a bank transfer directly to a valid bank account in the name of The Lung Cancer Patient Association. Invoice must be sent from The Lung Cancer Patient Association to **MSD**.


